

**PARENTAL PERMISSION CONSENT, RELEASE FROM LIABILITY

I \_\_\_\_\_, parent or legal guardian of \_\_\_\_\_, a minor, do hereby consent to his/her voluntary participation in the 2008 Foxboro Jaycees / Foxboro Orpheum / Bay Colony Productions Haunted House and hereby forever RELEASE, discharge, and covenant to hold harmless the Foxboro Jaycees / Foxboro Orpheum / Bay Colony Productions, as well as its officers, members, agents, employees, volunteers, insurers, attorneys, servants, affiliates, and their successors and assigns and the Town of Foxborough, as well as its elected and appointed officials, committees, agents, employees, volunteers, insurers, attorneys, servants, affiliates, and their successors and assigns from any and all manner of claims, actions and causes of action, agreements, judgments, settlements, damages, and demands whatsoever, known or unknown, at law or in equity, on account of, or in any way growing out of, directly or indirectly, all known and unknown personal injuries or property damage which I may now, or hereafter have as the parent of said minor, and also all manner of claims, actions and causes of action, agreements, judgments, settlements, damages, and demands whatsoever, known or unknown, at law or in equity, which said minor has or hereafter may acquire, either before or after he/she has reached his/her majority, resulting from his/her participation in the 2008 Foxboro Jaycees / Foxboro Orpheum / Bay Colony Productions Haunted House. The undersigned parent or legal guardian understands that the performance requires the Child, to be dressed in costume including make-up and/or mask, to conduct activities to be carried out in complete darkness punctuated by strobe light conditions and specifically undertake activities which are designed to frighten guests. The parent or legal guardian agrees the s/he remains responsible for the minor Child and the minor child's activities at all times and neither the Foxboro Jaycees / Foxboro Orpheum / Bay Colony Productions, nor the Town of Foxborough are assuming any responsibility for conservatorship of the child's activities. If the Child is found not performing the assignment agreed upon, the parent or legal guardian will be notified and remove the Child from the premises.

I acknowledge that I have read this form in its entirety and enter into this Agreement after having had ample opportunity to consult with counsel, and I do so knowingly and voluntarily, with complete understanding of the terms and the conditions of the Agreement.
